CALL TO ORDER

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. ITEM #3 MID-WEST MOPARS EVENT ON 08-05-17 Lee moved and Petersen seconded the motion to approve request by Rick Hulse, Club Coordinator for Mid-West Mopars Organization, to close Victoria Lane from East State Farm Road to East Walker Road on Saturday, August 5, 2017 for a motor sport event to include exhibition drag racing. Roll call vote: "AYE": Nisley, Baker, Petersen, Pedersen, Lee, Carman, Steinbeck, Ostendorf. "NAY": None. Motion carried.

ITEM #4 308 BMX TRACK AT WALKER RD. AND SOUTH Lee moved and Carman seconded the motion to enter into an agreement with 308 BMX for the use of a portion of the tract of land referred to as South Park, located in the Southeast Quadrant of Walker Road and South Buffalo Bill Avenue for use as a

BMX site.

Brandon McCook and members of the 308 BMX Board told the Council they cannot apply for grants or ask for donations until they have the approval from the City to use the land. They said they have received non-profit status and do not want to lease the land but intend to keep it as a city park so anyone can use it. They believe the BMX track will be a positive improvement to the park land with minimal dust, lights and noise and will help the economy by bringing people to the area.

Josh Osterhoudt, Track Operator for Tri-City BMX in Kearney, told the Council the track in Kearney is in a city park and they do not have to pay any rental fees, just provide insurance to the national BMX organization and maintain the track.

Lee withdrew his motion, with the consent of Carman.

Lee moved and Baker seconded the motion to enter into an agreement with 308 BMX for the use of a portion of the tract of land referred to as South Park, located in the Southeast Quadrant of Walker Road and South Buffalo Bill Avenue for use as a BMX site pending discussion with the City on any lease fees contingent to use of a city park and conditioned on them raising the funds for the project in the next nine months.

Lee moved and Baker seconded the motion to amend the motion that 308 BMX needs to raise \$188,000.00 for the project in the next nine months. Roll call vote: "AYE": Nisley, Baker, Petersen, Pedersen, Lee, Carman, Steinbeck, Ostendorf. "NAY": None. Motion carried.

Lee moved and Baker seconded the motion to approve Ordinance No. 3967 on its first reading. Roll call vote: "AYE": Nisley, Baker, Petersen, Lee, Carman. "NAY": Pedersen, Steinbeck, Ostendorf. Motion carried.
