MINUTES OF THE REGULAR CITY COUNCIL MEETING December 19, 2017; 7:30 p.m.

CALL TO ORDER

Invocation was given by Brent Montgomery and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 7:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Baker, Petersen, Pedersen, Lee, Steinbeck, Ostendorf. Carman was absent. Mayor Dwight Livingston presided and City Clerk Angela Gilbert recorded the proceedings.

Leanne Anderson, First National Bank, told the Council the Revised Statement of Investment Policy will increase invested equity of the funds from 20% to 40%, extend the use of the bonds to intermediate bonds, lengthen the maturity time up to 10 years and allow additional funds that are held in CDs to be managed by First National Bank. She said the funds had \$2.3 million at the end of November, with \$440,000 currently being held in CDs.

Pedersen moved and Baker seconded the motion to strike paragraph D. Objective from the Statement of Investment Policy for the City of North Platte for the benefit of the John Newburn Funds.
