## MINUTES OF THE REGULAR CITY COUNCIL MEETING June 4, 2019; 7:30 p.m.

## CALL TO ORDER

Invocation was given by James Trippett and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 7:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Backenstose, Petersen, Lee, Rieker, Ostendorf. Lucas and Carman were absent. Mayor Dwight Livingston presided and City Clerk Angela Gilbert recorded the proceedings.

Mayor Livingston stated that a current copy of the Open Meetings Act of Nebraska is posted on the wall at the back of the Council Chambers.

Notice of the meeting was given in advance thereof by posting in three public places in the City as follows: North Platte Public Library, Lincoln County Courthouse, City Hall, the designated method for giving notice (certificate of posting), being attached to these minutes. Proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

ITEM #6 MCNEW FIRST SUBDIVISION, 1605 NORTH DODGE ROAD Lee moved and Petersen seconded the motion to adopt recommendation by the North Platte Planning Commission for preliminary and final approval of McNew First Subdivision located at 1605 North Dodge Road with a variance to City Code of Ordinances Section 155.093 (D) the depth of a lot shall be no more than 3 times the width of the lot at the building line. ITEM #7 CONDITIONAL USE PERMIT, 1605 NORTH DODGE ROAD Mayor Livingston declared a Public hearing on recommendation by City of North Platte Planning Commission on an application by Terry and Nancy McNew for a Conditional Use Permit to allow a mother-in-laws quarters on the same lot as a main dwelling located in an R-4 Dwelling District on property described as the North 62' of the South 214' of the West 145' and part of the E 151.9' of Lot 31 Lincoln County Highway 4<sup>th</sup> Addition North Platte, Lincoln County, Nebraska (Proposed Lot 1 McNew First Subdivision) with the condition that the existing mobile home be removed no later than June 1, 2020 and the conditional use be discontinued at that time.

jurisdiction. 2) The use does have adequate water, sewer, and drainage facilities. 3) Ingress and egress is so designated as to minimize traffic congestion in the public streets. 4) The use does in all other aspects conform to the applicable regulations of the district in which it is located. 5) The use is in harmony with the character of the area and the most appropriate use of the land. ITEM #8 ORD 4009 ON 1<sup>ST</sup> READING Mayor Livingston declared a Public hearing to adopt Ordinance No. 4009 to rezone certain lands from an R-4 Dwelling District to an I-1 Light Industrial District located at 1302 North Roosevelt Avenue.

ITEM #9 CONDITIONAL USE PERMIT, 521 NORTH SPLINTER ROAD Mayor Livingston declared a Public hearing on recommendation by City of North Platte Planning Commission on an application by Michal Ekdahl, owner, and Verizon Wireless Communications, lessee, for a Conditional Use Permit to allow a 146' Wireless Telecom Tower to be located in an A-1 Agricultural District on property at 521 North Splinter Road and described as Lot 2 Bryner's 2<sup>nd</sup> Replat, Lincoln County, Nebraska.

Jeanna Koubek, 6419 West Koubek Road, told the Council she is against the cell tower being put in that location and she fears for the safety of the birds, cattle and children in the area. She does not believe there has been enough research done on the harmful effects of these types of towers. She also questioned whether all of her neighbors had been notified of the proposed tower. She requested Exhibit "A" Environmental Health Trust Outdated

FCC "Safety" Standards and Exhibit "B" US Department of the Interior warns: Communication Towers Threaten Birds – EMF Safety Network be entered into the record of the Minutes.

Jeffrey Skinner, representing Verizon Wireless, told the Council all residents in the area were notified and there is a need for a tower in this location as it will serve the western edge of town and relieve signal congestion for Bailey Yard. He stated the height is low enough to not require lights, there will be a chain link fence surrounding the tower, and they operate under federal safety standards so there should be no health concerns or issues with hunting and fishing. He said the tower has been approved by all of the required federal, state and local offices. He also requested Exhibit "C" 23 pages relating to the Conditional Use Permit included in the City Council packets be entered into the record of the Minutes.
