MINUTES OF THE REGULAR CITY COUNCIL MEETING November 19, 2019; 5:30 p.m.

CALL TO ORDER

Invocation was given by Pastor John Stone and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Backenstose, Petersen, Lucas, Lee, Rieker, Ostendorf. Carman was absent. Mayor Dwight Livingston presided and City Clerk Angela Gilbert recorded the proceedings.

Mayor Livingston stated that a current copy of the Open Meetings Act of Nebraska is posted on the wall at the back of the Council Chambers.

Notice of the meeting was given in advance thereof by posting in three public places in the City as follows: North Platte Public Library, Lincoln County Courthouse, City Hall, the designated method for giving notice (certificate of posting), being attached to these minutes. Proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

Jeremiah Blakey, Director of Gov't Affairs for Charter Communications in Nebraska, told the Council they have been working on updating this Ordinance and the Franchise Agreement we have with Charter Communications for several months as they are both outdated. He said the Franchise Agreement will come back to the City Council after the Ordinance passes.
