MINUTES OF THE REGULAR CITY COUNCIL MEETING March 3, 2020; 5:30 p.m.

CALL TO ORDER

Invocation was given by Linda Logsdon and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Petersen, Lucas, Lee, Carman, Rieker, Ostendorf. Backenstose was absent. Mayor Dwight Livingston presided and Dawn Miller, Director of Finance/Administration recorded the proceedings.

Mayor Livingston stated that a current copy of the Open Meetings Act of Nebraska is posted on the wall at the back of the Council Chambers.

ITEM #6 AIRPORT AUTHORITY BOND ISSUE Lee moved and Petersen seconded the motion to adopt Resolution to confirm prior approval of the Airport Authority's permitted additional levy of up to three and one-half cents (3.5 cents) shall continue to apply with respect to the Airport Authority's outstanding bonds and proposed new issue of bonds for airport purposes.

Sam Seafeldt, Airport Manager, informed the Council that the Bonds would be issued for capital projects as discussed during the 2019-2020 Budget and to refinance existing bonds.

John Trecek, Ameritas Investment Corp., told the Council this financing will result in reduced annual debt service costs to the Airport Authority and the Bonds will mature in 2039.
