MINUTES OF THE REGULAR CITY COUNCIL MEETING March 17, 2020; 5:30 p.m.

CALL TO ORDER

Invocation was given by Jeremy Rinke and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Backenstose, Petersen, Lucas, Lee, Rieker, Ostendorf. Carman was absent. Mayor Dwight Livingston presided and Dawn Miller, Director of Finance/Administration recorded the proceedings.

Mayor Livingston stated that a current copy of the Open Meetings Act of Nebraska is posted on the wall at the back of the Council Chambers.

Notice of the meeting was given in advance thereof by posting in three public places in the City as follows: North Platte Public Library, Lincoln County Courthouse, City Hall, the designated method for giving notice (certificate of posting), being attached to these minutes. Proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

ITEM #10 PRECISION CONCRETE CUTTING FOR TRIP HAZARD REPAIR Lee moved and Petersen seconded the motion to approve the Trip Hazard Repair Proposal from Precision Concrete Cutting for repairing and mitigating sidewalk tripping hazards at certain City Parks and Buildings in the amount of \$51,631 and authorize Mayor to sign all necessary documents and contracts. ITEM #12 ORD 4028 ON 1ST Mayor Livingston instructed Ordinance No. 4028 amending Section 110.01 of the Code of Ordinances of the City of North Platte to add an Occupation Tax on Class L Craft Brewery Liquor Licenses (Brew Pubs) and deleting and updating outdated Occupation Tax Fees to be read by title on its first reading. Lee moved and Petersen seconded the motion to approve Ordinance No. 4028 on its first reading.

Lee moved and Lucas seconded the motion to amend \$500 to \$100 on the Occupation Tax portion to match Class C. Roll call vote: "AYE": Backenstose, Lucas, Lee. "NAY": Nisley, Petersen, Rieker, Ostendorf. "ABSENT": Carman. Motion failed 3-4.

Randall Skates, 608 South Belmont, told the Council that typically brewery's sell a premium product that is high in value. He also said \$400 should not make a big difference.

Roll call vote on main motion: "AYE": Nisley, Petersen, Lucas, Ostendorf. "NAY": Backenstose, Lee, Rieker. "ABSENT": Carman. Motion carried.

ITEM #13 TABLE ORD 4029 Lee moved that the rule requiring Ordinance No. 4029 to create Water Extension District No. 265 including the south 150' of Lot 66 of Neville's Subdivision of Sections 34 and 27, Township North, Range 30 West of the 6th PM, except the east 140' of the south 42' thereof, and, the south 150' of the east 172' of Lot 65 of Neville's Subdivision of Section 34 and 27, Township 14 North, Range 30 West of the 6th P.M. and, the north 150' of Block 75 of Neville Subdivision Parcel Map of Tract B, and, the east 140' of the south 42' of Block 66 of Neville's Subdivision to North Platte, Nebraska, and, the north 150' of Lot 74 of Neville's Subdivision to the City of North Platte, Lincoln County Nebraska to be read on three different dates be suspended. Tom Vedder, 1007 Roosevelt, told the Council he is opposed to the Water Extension District and asked if a Water Connection District is possible.

Tim Kelly, 1621 East 8th Street, and Cliff Reichenberg, Lot A, Block 75 owner, told the Council they have no need for City water.

Rieker moved and Petersen seconded the motion to table action on Ordinance No. 4029 and rewrite Water Extension District No. 265 as a Water Connection District and reconsider a previous district. Roll call vote: "AYE": Nisley, Backenstose, Petersen, Rieker, Ostendorf. "NAY": Lucas, Lee. "ABSENT": Carman. Motion carried.

ITEM #14 FIRST STATE BANK AS A WARRANT LENDER Lee moved and Petersen seconded the motion to adopt Resolution providing for the designation of First State Bank as a warrant lender; authorizing the execution and delivery of a Warrant Purchase Agreement with such designated warrant lender and referring to and incorporating the terms and conditions of Ordinance No. 3874 relating to warrant financing. Roll call vote: "AYE": Nisley, Backenstose, Petersen, Lucas, Lee, Rieker, Ostendorf. "NAY": None. "ABSENT": Carman. Motion carried.

ITEM #15 ISSUE WARRANTS TO THREE DIFFERENT VENDORS Lee moved and Petersen seconded the motion to adopt Resolution approving claims and authorizing the issuance of a warrant to ATC Group Services LLC in the amount of \$443.75; two warrants to Midlands Contracting in the amounts of \$3,083.58 and \$2,084.17 and a warrant to Paulsen, Inc. in the amount of \$191,854.08 to pay approved claims and referring to and incorporating the terms and conditions of Ordinance No. 3874 relating to warrant financing passed and approved on May 21, 2013.
