MINUTES OF THE REGULAR CITY COUNCIL MEETING April 7, 2020; 5:30 p.m.

CALL TO ORDER

Invocation was given by Andrew Lee and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers and the City Hall Conference Room at 211 West 3rd Street. Present were Nisley, Backenstose, Petersen, Lucas, Lee, Rieker, Ostendorf. Carman was absent. Mayor Dwight Livingston presided and Dawn Miller, Director of Finance, recorded the proceedings.

Mayor Livingston stated that a current copy of the Open Meetings Act of Nebraska is posted on the wall in the Council Chambers and the Conference Room.

Shannon Vanderheiden, Executive Director of West Central District Health Department, explained that the Department is requesting that the City approve and authorize the Mayor to sign the Memo of Understanding. She indicated that this is being requested from all counties and communities they serve and the language was provided by attorneys at the State level and sent down to all Health Districts. She indicated that the City and West Central District Health Department already work in close partnership. She also said a very close partnership exists between the Governor's Office and the local Health Districts when a Health Directive needs to be issued at a local level.
