CALL TO ORDER

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Tryon, Volz, Lucas, Garrick, Carman, Rieker, Woods. Nisley was absent. Mayor Brandon Kelliher presided and City Clerk Angela Gilbert recorded the proceedings.

Rieker moved and Lucas seconded the motion to approve Resolution Consenting to a Transfer of Control of Franchise between the City of North Platte and Allo Communications, LLC for the remainder of the original contract term.

Brad Moline, President of Allo Communications, told the Council he does not expect any big changes with the transfer and the leadership of the company is the same, only the financing has changed.

Rieker moved and Garrick seconded the motion to approve the \$200,000 performance based three-year loan requested by Credit Management Inc. according to the guideline recommendations from the Quality Growth Fund Citizens Review Committee and authorize City management to write the contract.

Dave Faimon, CFO of Credit Management, Inc., told the Council they have clients in North Platte and their other offices in the state are full so they are moving forward with opening an office in North Platte; they have leased a building downtown and plan to hire and train new employees as soon as they can. He stated they are looking for community support and are accepting of the counter proposal the Quality Growth Fund Committee is recommending.

Volz moved and Lucas seconded the motion to approve the recommendation of the Quality Growth Fund Committee to provide \$250,000 in Quality Growth Funds in partnership with the North Platte Area Chamber and Development Corporation and its partners that are providing \$250,000 in local funds; and apply for \$500,000 from the Nebraska Rural Workforce Housing Fund and approve \$30,000 for administrative assistance to the Lincoln County Community Development Corporation to oversee the rehabilitation portion of the housing program.

Gary Person, President of North Platte Chamber/DEVCO, told the Council that housing and job creation go hand-in-hand and if you build more houses, you build your population. He said the application for funding is due at the end of January 2021, there is 50% local match needed from community entities and there will not be an opportunity to apply for the program again for three years.

Rieker moved to amend the motion to provide \$150,000 in Quality Growth Funds instead of \$250,000.

Rieker withdrew his motion.

ITEM #9 CONDITIONAL USE PERMIT, 221 WEST 11TH STREET Mayor Kelliher declared a Public hearing on recommendation by the North Platte Planning Commission for approval of an application by James Hassett for a Conditional Use Permit to allow living quarters situated in an office building in a B-2 Highway Commercial District located at 221 West 11th Street. No one appeared.

Lucas moved and Rieker seconded the motion to close the hearing. Roll call vote: "AYE": Tryon, Volz, Lucas, Garrick, Carman, Rieker, Woods. "NAY": None. "ABSENT" Nisley. Motion carried.

Lucas moved and Carman seconded the motion to find the request for a Conditional Use Permit to allow living quarters in an office building located at 211 West 11th Street meets the minimum standards stated in the North Platte Code of Ordinances Section 156-322 and approve and grant the

Conditional Use Permit requested with the condition that all elements of the application are complied with based on the following factual findings:

- 1. The use shall conform to all applicable ordinances, laws and regulations of any governmental jurisdiction.
- 2. The use shall have adequate water, sewer, and drainage facilities.
- 3. Ingress and egress shall be so designated as to minimize traffic congestion in the public streets.
- 4. The use shall in all other respects conform to the applicable regulations of the district in which it is located.
- 5. The use shall be in harmony with the character of the area and the most appropriate use of the land.

She said they have similar agreements with all of the villages and cities in their district and they have a governing board that meets quarterly.
