## MINUTES OF THE REGULAR CITY COUNCIL MEETING August 17, 2021; 5:30 p.m.

## CALL TO ORDER

Invocation was given by Jeremy Rinke and the pledge of allegiance was recited.

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Tryon, Volz, Lucas, Garrick, Carman, Rieker, Woods. Mayor Brandon Kelliher presided and City Clerk Angela Gilbert recorded the proceedings.

Mayor Kelliher stated that a current copy of the Open Meetings Act of Nebraska is posted on the wall at the back of the Council Chambers.

Notice of the meeting was given in advance thereof by posting in three public places in the City as follows: North Platte Public Library, Lincoln County Courthouse and City Hall; the designated method for giving notice (Certificate of Posting) is attached to these Minutes. Proceedings hereafter shown were taken while the meeting was open to the attendance of the public.

## **CONSENT AGENDA**

Garrick moved and Carman seconded the motion to approve the Consent Agenda as follows:

- 1. Approve Minutes of August 3 and 10, 2021.
- 2. Send the application of Jenifer Lockhart-Lusk as Liquor License Manager at Ruby Tuesday located at 2320 South Jeffers Street to the Liquor Control Commission with no recommendation.
- 3. Approve the appointment of Jim Backenstose to the Board of Adjustment.

ITEM #4 CONDITIONAL USE PERMIT, VICTORIA LANE AND EAST WALKER ROAD Mayor Kelliher declared a Public hearing on a recommendation by the North Platte Planning Commission on an application by Prospect Enterprises, LLC for a Conditional Use Permit to allow a horse race track and associated improvements located in an I-1 Light Industrial District in the northeast corner of the intersection of Victoria Lane and East Walker Road.

Brian Jorde, representing North Platte Exposition and Horse Racing, told the Council they are excited about the location being moves forward.

Gina Kuenning, 201 South Maloney Drive, told the Council that to her knowledge if you are running a race track, it is illegal to run your own horses. She stated that a casino and race track would be great for North Platte, but she does not believe this is the one we want and we need to do it right the first time.

Lucas moved and Volz seconded the motion to close the Public hearing. Roll call vote: "AYE": Nisley, Tryon, Volz, Lucas, Garrick, Carman, Rieker, Woods. "NAY": None. Motion carried.

Rieker moved and Woods seconded the motion to find the request for a Conditional Use Permit to allow a horse race track and associated improvements located in the northeast corner of the intersection of Victoria Lane and East Walker Road does not meet the minimum standards stated in the North Platte Code of Ordinances Section 156-322 and deny the Conditional Use Permit as requested based on the following factual findings: The applicant has not met the following minimum standards stated in The North Platte Code of Ordinances Section 156-322.

Rieker moved to withdraw his motion, with the consent of Woods.

Lucas moved and Volz seconded the motion to find the request for a Conditional Use Permit to allow a horse race track and associated improvements located in the northeast corner of the intersection of Victoria Lane and East Walker Road meets the minimum standards stated in The North Platte Code of Ordinances Section 156-322 and approve and grant the Conditional Use Permit requested with the condition that all elements of the application are complied with and with the following conditions:

- 1. A fully executed Development Agreement with the City of North Platte must be in place prior to construction. The Development Agreement will include but not be limited to regulations regarding water, sanitary sewer, subdivision, drainage, storm water management, landscaping, parking, driveways, paving, decommissioning, traffic, electric utility layout and designated smoking areas.
- 2. Construction of the track and infrastructure, including utilities, drainage, and street paving must be completed within two years of the date of issuance of the conditional use approval.

3. The track must be constructed at a minimum of 5/8 of a mile meets the minimum standards stated in The North Platte Code of Ordinances Section 145-322.

based on the following factual findings:

- 1. The use shall conform to all applicable ordinances, laws and regulations of any governmental jurisdiction.
- 2. The use shall have adequate water, sewer, and drainage facilities.
- 3. Ingress and egress shall be so designated as to minimize traffic congestion in the public streets.
- 4. The use shall in all other respects conform to the applicable regulations of the district in which it is located.
- 5. The use shall be in harmony with the character of the area and the most appropriate use of the land.

Roll call vote: "AYE": Volz, Lucas, Garrick, Carman. "NAY": Nisley, Tryon, Rieker, Woods. Mayor Kelliher voted "AYE" and the motion carried.
