# MINUTES OF THE REGULAR CITY COUNCIL MEETING February 15, 2022; 5:30 p.m.

### CALL TO ORDER

Invocation was given by Bob Deardoff and the pledge of allegiance was recited.

## **ROLL CALL**

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Mike Drain, representing Central Nebraska Public Power in Holdrege, told the Council they prefer not to be in the City limits, but they understand the reasoning and they do not object to the annexation. He stated they are working with the City to create an Overlay District to make allowances for the recreational usage on their property.

Dave Behle, representing Dawson Public Power, told the Council there is critical infrastructure in the area and they intend to continue to serve the annexed property.
