Attorney Mike Bacon told the CRA that the Redevelopment Plan and Contract have been signed and the City has approved the sale of land for the project for the appraised value of \$142,500. He said that Vice Chair Stefka will certify the construction contract and loan committal and all of the documents will be signed at the same time at the closing.

Attorney Bacon told the CRA that this is Step two of the process. He stated that there will be a Special Warranty Deed for the property, which will limit the CRA's liability and the Title Insurance will insure that all items have been met before the closing documents are signed.
