

MINUTES OF THE REGULAR CITY COUNCIL MEETING  
September 19, 2023; 5:30 p.m.

- CALL TO ORDER Invocation was given by Joel Miller and the pledge of allegiance was recited.
- ROLL CALL A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Tryon, Volz, Lucas, Rieker, Woods. Garrick and Flanders were absent. Mayor Brandon Kelliher presided and City Clerk Angela Gilbert recorded the proceedings.
