### MINUTES OF THE REGULAR CITY COUNCIL MEETING November 7, 2023; 5:30 p.m.

# CALL TO ORDER

Invocation was given by Craig Fabik and the pledge of allegiance was recited.

#### ROLL CALL

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Tryon, Volz, Lucas, Garrick, Flanders, Woods. Rieker was absent. Mayor Brandon Kelliher presided and City Clerk Angela Gilbert recorded the proceedings.

adjoining accretion land, into the corporate limits of the City of North Platte consisting of approximately 158 acres.

Eric Seacrest, 109 South Maloney Drive, stated that the number one problem our town is facing is housing and people are leaving our state because of housing. He stated that this annexation will not solve the problem, but it will help private enterprises do something that is good.

Cassie Condon, representing the North Platte Chamber, read a letter to the Council from Gary Person, President of the North Platte Chamber in his absence. His letter stated that this is a prime opportunity for housing, there are developers ready to develop and property ready to be annexed and he asked the Council to approve this for development.
