MINUTES OF THE REGULAR CITY COUNCIL MEETING February 6, 2024; 5:30 p.m.

CALL TO ORDER

Invocation was given by Father Jonathan Sorensen; St. Patrick's Catholic Church and the pledge of allegiance was recited.

ROLL CALL

A regular meeting of the Council of the City of North Platte, Nebraska was convened in open and public session at 5:30 p.m. in the City Hall Council Chambers at 211 West 3rd Street. Present were Nisley, Tryon, Volz, Lucas, Garrick, Rieker. Woods arrived at 5:35 p.m. Flanders was absent. Mayor Brandon Kelliher presided, and Renee White, Deputy City Clerk recorded the proceedings.

Eric Seacrest, 109 S. Maloney Drive, stated that the rezoning was practically perfect. Affordable Housing is needed, and the project would be a step in the right direction of extending Francis Street.
